Supervisors Report: Cammie

• Cammie received Clerk fees in the amount of \$633.00; July Judicial Fees in the amount of \$377.00, Cammie received a check in the mount of \$149.06 from the Chenango County Treasurer, Payment for the Vonlangen dog vet bill for \$200.00, for a total of \$1,359.06 in General Checking.

Highway Superintendent Report: Rick

- Buckley Road is a nightmare/ disaster. The new material was put down to thick and damp, which caused it to be unstable and not pack. Weather also contributed to it not drying and packing properly. People drove over it causing problems with the material getting on vehicles. Need to finish it with either cold mix or hot mix and chip seal it as soon as it dries.
- The Cueball Culvert is now open. Just need to get the Guardrails up.
- Another culvert to go in before October 15, 2022. This project will only take one person.
- The price of Road Sand has gone up. We will haul 1/3 ourselves and 2/3 by a hauler.
- Wylie-Horton road will be closed up by Cueball to get that pipe fixed.

Cammie would like approval to purchase new copier/Fax machine for the Town Office for between \$5,000 and \$10,000. George made the motion to purchase. John seconded. All are in favor.
Cammie asked permission to purchase a new Laptop/ printer/fax/scanner for the Highway Superintendent. George made a motion to purchase. John seconded. All are in favor.
