**Reports**

Supervisors: Cammie

- Cammie received March Clerks Fees in the amount of \$106.00 and March Penalty Fees in the of \$1588.20.
- Cammie went over The Town Expense Report with the Board. She will give a quarterly budget report next month.

Assessor: Brian

- Brian will be sitting with the Tentative Roll starting May 1<sup>st</sup>. The Grievance Day will be Wednesday May 24, 2023 from 4-8 p.m.

Highway Superintendent: Rick

- County asked Rick about doing the roadside mowing for the County roads in Coventry the \$85 a mile and Rick would like to decline as it is more expensive than what the pay would be.
- Rick bought 40 ton of salt at \$3,000 and placed near the sand pile. This will be used for any Ice event.
- The crew has been out patching all the potholes and sweeping the roads which has uncovered more.
- Going to work on Stone Hill Road which is a CHIPS Road and Stiles Road which is not CHIPS. Rick may need to get a contractor for Stiles Road.
- The Highway Dept. is down 1 man for now.
- The Crew has gone to 10-hour days so they will four days a week.
- CHIPS finish Buckley Road, Smith Pond and stone Cueball from 235 to Seymour and Seymour to Gray center of Town Road.
- Rick mentioned that there are some road signs that need to be replaced. This will be on next month's bills.
